Retail Customer Considerations for Over-the-Counter Pesticides

Talk To Your Customers:

- Have they <u>identified</u> the pests and know <u>which chemicals</u> to use?
- Do they know of <u>alternative</u> treatments?
- Do they know how to view the <u>labels</u> and follow label instructions?
- Do they know how the product will affect <u>pets and beneficial insects</u>?
- Do they know how to get <u>safety infor-mation</u> and use protective gear?
- Do they know how to <u>safely use</u> the product, especially concentrates?
- Do they know which <u>application conditions</u> apply (sunlight, season, rainfall, mowing, watering, etc.)?
- Do they know about the possible need for <u>repeat applications</u>?
- Do they know how to properly and safely <u>clean up</u> applicators and spills?
- Do they know how to properly <u>dispose</u> of unused product and containers?

Many pesticides are harmful to people, animals and our environment. Pesticide use often requires repeat applications. Over time some pests become resistant which reduces pesticide effectiveness.

Product Display Area Management:

- A store's chemical products area has <u>potential for injury</u> to customers.
- Many products are <u>concentrates</u> of toxic chemicals in glass containers on shelves.
- Some chemicals are <u>sensitive</u> to strong sunlight or extremes of temperatures.
- Many strong pesticide chemicals require special types of absorbents and other supplies for proper spill cleanup.
- <u>Disposal of waste</u> cleanup materials may require special handling.
- <u>Spill cleanup kits</u>, along with kit use instructions, should have easy access.
- Employees should be <u>trained</u> in chemical handling, stocking and spill cleanup.
- Floor <u>managers should be knowledgea-ble</u> to address customer's questions and concerns about chemical use, safety and proper disposal.
- <u>Shelves</u> should be sturdy, and containers placed on shelves to avoid falls.
- <u>Aisles</u> between product displays should be wide enough to minimize bumping by customers and their shopping carts.

Pesticide Use Tips for Customers:

- <u>Read labels</u> carefully for important information on product use, safety and cleanup.
- Be certain <u>which pesticide</u> is the best option for controlling the target pests.
- Use the manufacturer's <u>hotline and customer service</u> for safety questions.
- Minimize <u>pesticide runoff</u> by not applying during or just before rainfall runoff.
- When <u>mixing solutions</u> from concentrates, make sure the container is labeled with the product, intended use, date and expiration.
- <u>Use only the amounts</u> and application procedures recommended by the manufacturer. Applying overly concentrated solutions can have dangerous consequences for the environment.
- Always wear the recommended <u>safety</u> <u>gear</u> when working with pesticides.
